Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) IT return of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate/challan and Provident Fund Registration Certificate.
- b) Audited balance sheet to satisfy the **net worth** for the year of **2012–2013** of the intending party **not less than Rs.03 lacs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- 2. The party should have at least **one(01) year** of working experience of doing similar nature of job in a single order value not less than **Rs. 04** lacs during the last **05** years in a thermal power station of 210MW capacity or above.
