Tender Notice for “construction of drainage system connected to common sump, below ESP of unit #4 & 5 with guard wall at BkTPP.”

Bakreswar Thermal Power Project (BkTPP) invites **3-part Commercial (Part I – Bid Guarantee (EMD) Part II - Bid qualification and Part III - Price Offer)** offer for undertaking the rate contract for the job “construction of drainage system connected to common sump, below ESP of unit #4 & 5 with guard wall at BkTPP.”

1) Issue of Tender Document: The tender document shall be available from the **Chamber of Sr.Manager [Civil-IPH], Technical Bldg. (3rd floor), BkTPP** from 10:00 Hrs. to 11:30 Hrs. upto 07.01.2014 except Holidays & Sundays. The tender document shall be issued against submission of **application for issuance of Tender** at receipt section in Administrative Building and **cost of tender paper. For collection of tender paper**, the agency must send their **authorized person with office seal**.

2) Cost of Tender Document: The cost of tender document shall be taken in the form of non-refundable **Demand Draft/Pay order** amounting **Rs.500.00** (Rupees five hundred only) drawn in favour of **“The West Bengal Power Development Corporation Ltd ” payable at United Bank of India, Bk.T.P.P.** for the cost of tender documents. Tender paper shall not be issued against cash/cheque/money order /post.

3) The last date of application and purchase of tender paper: 07.01.2014 up to 11:30 Hrs.

4) The pre-bid discussion will be held on 10.01.2014 at 15:00 Hrs at the office of Sr. Manager (C-IPH), Technical Bldg. (3rd floor), BkTPP.

5) The date & time of submission of Bid: On 15.01.2014 Up to 15:00 Hrs.

6) The date & time of opening of part- I, II of the Bid: 15.01.2014 at 15:00 Hrs at the office of Sr. Manager (C-IPH), Technical Bldg. (3rd floor), BkTPP.

7) The date & time of opening of part- III i.e. Price bid will be intimated in due course to the qualified bidder.

8) The Bid Guarantee (EMD) is to be submitted along with the bid in the form of Demand Draft/Pay order amounting Rs.23,000.00 (Rupees twenty

three thousand only) **drawn in favour of “The West Bengal Power Development Corporation Ltd” payable at any Nationalized bank at Suri or United Bank of India, Bk.T.P.P.** The Bid Guarantee (EMD) of unsuccessful bidder shall be released in due course of time without any interest but may be forfeited at the sole discretion of WBPDC in case of submission of any false document in support of technical or financial credential of the bidder.

However, necessary relaxation in the Bid guarantee amount maybe allowed to the bidder, if they are governed by any particular Circular/Administrative order, providing for the same on production of supporting documents.

9) Acceptance of offers is subject to submission of valid Professional tax clearance certificate [up to date] , Income Tax [up to date] and PAN No , Service Tax registration No , Company PF Code No. etc.

10) It shall be obligatory and imperative on the part of the Tenderer to collect all the relevant information and Data pertaining to the Tender in question including deployment of manpower, prevailing wages of unskilled manpower at BkTPP, requirement of extending Provident Fund, compliance with the provisions of Contract Labour (Regulation & Abolition) Act, 1970, Employees’ Compensation Act, 1923, Labour License and compliance with the provisions of Factories Act, 1948 and all other Statutory and related Rules and Regulations and procedural formality in connection therewith and other requirements incidental thereto or connected therewith.

11) The interested agencies may inspect the site & satisfy themselves before submission of tenders. The bidder must confirm in writing while submitting the tender that he has quoted rates understanding the scope & area of work, all terms and conditions of tender documents, mode of deployment of manpower at BkTPP, actual site conditions & other related aspects. Deviation in any respect, expressed anywhere in the three part bid document, will not be accepted.

12) Qualification of the Bidder: The application for issuance of tender is open to any single Bidder who is a well established and reputed company meeting the following criteria:

(a) Financial ability: The bidder shall have adequate financial stability i.e. annual turnover shall be more than **Rs.28 Lakh (twenty eight Lakh)** and net worth not less than **Rs. 5 Lakh (five Lakh)** during any of the last three years. The copy of audited accounts with report for consecutive years of three years shall have to be furnished along with the offer.

(b) Credential of the work: The bidder shall have credential of successful completion of a similar type of job of value not less than Rs 11.00 lakh in a single contract during the last five years directly under the owner who shall be a Govt Organization/PSUs.

The bidder shall have to furnish authentic documents (like copy of final bill certificate, completion certificate and work orders along with schedule of works) in support of successful completion of similar type of work. The

bidder shall have at his own disposal sufficient number of workers including supervisor.

13) Price to be quoted: The bidder must quote the percentage rate/ item rate as will be in the BOQ of tender document for the job “construction of drainage system connected to common sump, below ESP of unit #4 & 5 with guard wall at BkTPP.”

14) Period of contract: The period of contract shall be from the actual date of commencement of work at site and/or as per the period mentioned in the LOI/work order. Contract period may be extended at the same rate and terms and condition of the order at the discretion of WBPDC provided the performance of the previous year is satisfactory. Apart from the unskilled labour, No escalation in rates due to any reason whatsoever shall be permitted.

15) Jurisdiction regarding this contract is limited to State of West Bengal as per provisions of Statutes.
