II. As an alternative the work may be done on joint venture basis. In case of joint venture the prime bidder (i.e. the main agency) shall have the experience to execute similar developmental work involving civil work (earth work by mechanical means including carried earth, brick work, concrete work etc.) and the associate bidder with whom joint venture is proposed should have the experience to execute Horticultural/ Gardening work.
