- (iii) Audited balance sheet for last three financial years.
- (iv) In case of manufacturing units, valid 'Consent to Operate' of WBPCB is to be furnished.
- (v) Experience of having successfully completed similar works of lifting of dry fly ash from silos of Thermal Power Plants in Bulklers / Browsers during last seven years ending last day of month previous to the one in which applications are invited, should be either of the following:-
  - a) One contract for lifting of a minimum of 80% of the annual bid quantity.
  - b) Two contracts each for lifting of a minimum of 50% of the annual bid quantity
  - c) Three contracts each for lifting of a minimum of 40% of the annual bid quantity.
