3.0 Scope of Work/Supply

- 4.0 Qualification Requirement and Eligibility Criteria for Bidders
- 5.1 Technical Requirement: The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conations as laid down in the Bid Document is liable to be rejected.

Must Conditions

1) The Bidder should be a designer and manufacturer of Coal fired Steam Generators of power plant units having rating not less than 200MW, which should be in successful operation and must have commissioned boiler (minimum two numbers) not less than 100MW for a period not less than 02 (two) years as on the date of bid opening. Supporting documents to be submitted.

AND

2) The bidder should have manufactured Coils/Panels of Re-heaters for steam generators MAKE: BHEL, as 1:1 replacement and such coils/panels manufactured by the bidder, should be in successful operation in atleast 01 (One) no. of Coal fired Steam Generators for different power plant units having rating not less than 200MW for a period not less than 02 (two) years as on the date of bid opening. Supporting documents to be submitted.

AND

3) If bidder may assign/sublet the contract to any sub-vendor, provided that the annual turnover of that sub-vendor should not be less than 50 (fifty) Crores in the last three F.Y.

AND

- 4) Bidder should provide List of all accessories which are required for replacement of RH coil. WBPDCL will not provide any kind of Drawing of RH Coil except tube Material Diagram.
- 5.2 Financial Requirement: In addition to the requirements stipulated at Para 5.1 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-
- 1) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to FY 2012-2013.
- 2) Has a minimum annual turnover of Indian Rupees 50 (Fifty) Crores each of the last three financial years.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-1 (Form-I) of Section-V of the tender documents.

- 3)Has an adequate design, manufacturing and/or fabrication capability including In-house Testing facility including Chemical & Physical and capacity available to perform the work properly and expeditiously within the time period specified.
- 4) Has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.
- 5) The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 7 years giving detailed particulars such as quantity, Size, contract value, name of the Owner, year of commissioning, etc. Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-I of the tender documents.

AND

- 5.3 Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.
- 5.4 Evaluation of WBPDCL shall be based on the information submitted by the bidder in response to these documents. WBPDCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- 5.5 The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in Attachment-5 of Section-V.
- The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
