Sealed Tender in prescribed form are invited for “**Annual rate contract for hiring of Six (06) nos.of Star Buses, 52 seater, Registration not before the year’2013 for transportation of employees of Kolaghat Thermal Power Station, WBPDC**” from the interested parties in four Step Bid system: Step-I : requisite amount of Earnest Money Deposit (Bid Guarantee Money), Step-II : submission of document against the Qualifying Requirement enumerated below, Step-III : Techno- Commercial Bid and Step-IV: PRICE BID, from the bonafide , resourceful contractors with the following Qualifying Requirement: -

(i) Posses valid VAT, IT, Professional Tax clearance certificate and Provident Fund A/C No., (ii) Have credentials regarding experience of execution of similar nature of jobs in a single contract amounting of **Rs. 35 (Thirty-five) Lakhs**, done at least once during last **five (5) years** directly under the owner i.e. Govt. Organisation /Undertaking Autonomous bodies, Reputed Industrial Houses under Indian Company’s act with satisfactory job completion certificate. (iii) also have documents holding possession of Labour License and Insurance as per Workmen’s’ Compensation Act for such job.,(iv) Audited Balance Sheet and Profit & Loss account for last three years. The total Net Worth of the intending party should not be less than **Rs.18 (Eighteen) Lakhs**. Solvency certificate from chartered accountant to be submitted.

Tender Paper can be obtained on the basis of written application from the Contract Cell under the Sr. Manager (Contract Cell) , KTPS on any working day (except Holidays/ Saturday) between 08-30 A.M. to 11-30 A.M. and between 02.30 to 04.30 P.M.on or before the date mentioned above, after depositing cost of Tender Paper at our CASH Section, (Cash hrs. between 10.30 A.M to 02.00 P.M) in cash only. Postal correspondence in this regard will not be entertained at all. Pre Bid discussion shall be held on **21.02.2014 at 3-30 PM** with the tenderers and the minutes of the said discussion shall be taken into account as a part of tender specification.

Sealed tenders of the parties who have deposited the requisite amount of Earnest Money in Step-I of the bid; the Step-II bid and Step-III thereof will be opened subsequently. After finalization of the Step-II bid i.e. fulfillment of the qualifying requirement and Step-III i.e. the Techno-Commercial part, the price part of the Bid i.e.Step-IV of the eligible tenderers will be opened later on. All tenders including its various parts shall be opened in presence of attending tenderers. The dates of opening of Price Part i.e. Step-IV shall be intimated to the competent tenderers in due course of time. The Earnest Money (interest free) should be deposited along with the tender offer in the form of Bank Draft /Call Deposit only on SBI/UBI/UCO/PNB, Mecheda Branch in favour of “The West Bengal Power Development Corporation Ltd.” in separate sealed envelope. No tender will be entertained without Earnest Money.

WBPDC reserves the right to split the contract among the qualified bidders at lowest price.

The Corporation reserves the right to accept/cancel any or all tenders without assigning any reason whatsoever. The WBPDC does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDC authority. The validity of tender will remain effective for 6 (six) months from the date of opening of Price-Bid of Tender.
