Sealed tenders in prescribed form are invited from interested, resourceful and experienced agencies for the following work at Sagardighi Thermal Power Project under The West Bengal Power Development Corporation Limited for which tender paper will be issued against submission and verification of the following documents in original:

- (i) Valid I.T., Service Tax, VAT, Professional Tax Clearance Certificates and Provident Fund A/c No.
- (ii) Credential of similar work done directly under a Government/ Quasi Govt. Organization/ reputed private organization during last seven (7) years reckoning from **31.01.2014** with a satisfactory completion certificate indicating the main work order no., value of the work, schedule and actual time of completion.

The value of work for similar type of job as mentioned, completed by the agency should be as follows:

- (a) **Three (3)** similar completed works each valuing not less than **Rs. 0.61 crore**
- (b) **Two (2)** similar completed works each valuing not less than **Rs. 0.76 crore**
- (c) **One (1)** similar completed work valuing not less than **Rs. 1.21 crore**

- (iii) The **average annual turnover** of the bidder during the last three (3) financial years ending **31st March 2013** shall not be less than **Rs. 0.46 Crore**

- (iv) **Net worth** of the bidder in each of the **last three (3) financial years** should be positive.

- (v) Audited balance sheet for last three financial years.
