The West Bengal Power Development Corporation Limited invites sealed tenders in three part bidding system containing Earnest money deposit (Part-I), Work experience and Techno-commercial bid (Part-II) and Price bid (Part-III) from competent, bonafide, resourceful, experienced and reputed engineering firms having experience in the work of interior works including Modular work station, Mechanical, Electrical, Illumination, Air conditioning system, Fire detection & fighting, CCTV, Access control, Public address system, Civil and sanitary, plumbing etc. for providing office accommodation at 5th and 6th floor of the Corporate office of the WBPDC, Bidyut unnayan Bhabon, SaltLake-700098, details of which are given below:-

Earnest Money Deposit (PART-I):

The EMD shall be deposited in the form of Demand Draft or BG in favour of “THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED” drawn on /issued by any Nationalized/Scheduled Bank, Kolkata along with tender papers in a separate sealed envelope. No tender will be entertained without Earnest Money. Bank Guarantee should have validity of three months from the date of opening of tender (Part-I & II).

Work experience and Techno-commercial Bid (PART-II):

- a) Self attested copies of the following documents are to be submitted by the Bidder in support of qualification:-
- (i) Completion certificate of the owner for successful completion of interior works including Modular work stations, Mechanical, Electrical, Illumination, Air conditioning system Fire detection & fighting, CCTV, Access control, Public address system, Civil and sanitary, plumbing etc. in the last 7 (seven) years reckoning from 31.01.2014, directly under any Government Organisation/ Undertakings/ Autonomous bodies/ any reputed concern and shall be in defect/ trouble free use at least for 1 (one) years from the date of handing over. The completion certificate shall clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.

The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-

- a) In Single order of value not less than- Rs. 1.82 Crore.
- b) In two orders each of value not less than- Rs. 1.14 Crore
- c) In three orders each of value not less than- Rs. 91 Lac

- (ii) Turnover:- Stated above.
- (iii) Net worth value:- Stated above.
- (iv) Current I. T., S. T., VAT, P. T. clearance certificates, P. F. code No., upto date PF payment details and electrical licence. Alternatively, such Bidders shall submit certificates from statutory authorities, indicating exemption and/or non-applicability with regard to any or all of I. T., S. T., P. T. clearance certificates and P. F. code no.
- (v) Audited Balance sheet & Profit & Loss Account for the last three years (viz. year 2010-11,2011-12, 2012-13).
- (vi) List of technical personnel and list of construction equipments and machineries owned by the agency with authentic documents.

Price Bid (Part-III):

Bidders shall have to quote the rate and amount in the 'priced schedule of works' in both figures and words.

Cost of Tender Paper: Rs.2000.00 in cash only (Non refundable) for each location.

Sale of Tender Paper: 26.02.2014 to 07.03.2014 from 11.00 hrs. to 15.00 hrs. on all working days (except Saturday / Holiday).

Tender document can be obtained on written request to the Deputy General Manager (Civil) -II, Corporate Office, WBPDC, Bidyut Unnyan Bhabon, 3/C LA Block, Sector-III, Salt Lake City, Kolkata – 700098.

Pre-bid discussion for the job shall be held on 13.03.2014 at 15.00 hrs. with the prospective bidders who purchased tender papers. The list of queries, if any, should be submitted on or before 12.03.2014 by 15.00 hrs. The information /clarifications given in that discussion shall form an integral part of the tender to be submitted.

Last date of submission of tender papers: 17.03.2014 upto 14.30 hrs. The Part-I & Part -II bids will be opened at 15.30 hrs. on the same date in presence of the participating tenderers. Sealed tenders for Part-II will be opened only of the parties who have deposited the requisite amount of Earnest Money in Part- I. Price Bid i.e Part –III will be opened at a later date which will be intimated to the qualifying bidders of Part-I & Part –II bids.

The Corporation reserves the right to accept / cancel any or all tenders or to split the work without assigning any reason whatsoever. The WBPDC does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDC authority. Tender papers are not transferable. The validity of tender will remain effective for 6 (Six) months from the date of opening of Price Bid of tender. All other details are available in the tender document.
