INVITATION FOR COMPETITIVE BIDS FOR MANUFACTURING/ SUPPLY, TESTING & DELIVERY OF FLANGELESS STRAIGHT COAL PIPE FOR KOLAGHAT THERMAL POWER STATION (6X210MW).

Kolaghat Thermal Power Station (KTPS) of The West Bengal Power Development Corporation Ltd. (WBPDC) invites sealed tenders containing technical, commercial and price offer in duplicate (one original & one copy) from eligible bidders for Manufacturing/ Supply, Testing, Delivery & Transport including transit insurance of Flangeless Straight Coal Pipe at KTPS.

1.0 Schedule of Completion of Supply:

Supply shall be completed in 02 (two) phases.

1st Phase: Item Sl.Nos.1 & 2 within July, 2014 (Approximately within 02 months from the date of LOA)

2nd Phase: Balance Items within January, 2015 (Approximately within 07 months from the date of LOA)

2.0 Details of Tender

On presentation of requisite money receipt against applicable cost of tender documents, the same will be handed over to the respective Bidder (s).

All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:

By Bank Guarantee or Demand Draft – INR 60,000.00 (Rupees Sixty Thousand only) issued by an Indian Branch of any scheduled bank. The Bank Guarantee shall remain valid for a period of 120 days (with additional claim period of 30days) from the date of opening of the tender. Details of the above and the other terms and conditions have been specified in the Conditions of Contract.

Govt./ Govt. Undertaking/SSI/NSIC units are exempted from deposition of Earnest Money. Valid documentary evidences shall be submitted by the bidder along with his bid to avail such exemption.

4.0 Qualification Requirement and Eligibility Criteria for Bidders

Technical Requirement: The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conations as laid down in the Bid Document is liable to be rejected.

Must Conditions

- i. Is a manufacturer/supplier, who regularly manufactures/supplies MS Spiral/Longitudinal Pipes of size 400MB or above conforming to latest Amendments of IS 3589 Fe 410 Code and has adequate technical knowledge and has relevant experience.
- ii. Has manufactured/supplied above specified Pipes during last 05 (five) years (as on the date of bid opening) as per the following:
 - a) One similar executed order having value not less than Rs.15,00,000.00.
OR
 - b) Two similar executed orders each having value not less than Rs.10,00,000.00.
OR
 - c) Three similar executed orders each having order value not less than Rs.7,00,000.00
- iii.
 - a) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to FY 2012-13.
 - b) Has a minimum annual turnover of Indian Rupees 20 (twenty) Million each of the last three financial years.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-1 (Form-I) of Section-V of the tender documents.

- iv. Bidder/Bidder's OEM has an adequate manufacturing and/or fabrication capability including In-house Testing facility including Physical & NDT and capacity available to perform the work properly and expeditiously within the time period specified.
- v. Bidder/Bidder's OEM has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.

AND

5.2 In addition to the requirements stipulated at Para 5.1 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-

5.2.1 The bidder shall submit at least two (2) un-priced Purchase Order copy of similar work executed by him during last five (5) years in any Govt./Govt. Under Taking/Enterprise Company or any reputed Industrial House or any Power Plant of WBPDC/NTPC as on the date of submission of Bid along with Goods Received Note (GRN) from the End-users for the respective supply.

5.2.2 The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 5 years giving detailed particulars such as quantity, quality, contract value, name of the Owner, year of supply etc.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-I of the tender documents.

AND

- Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.
- Evaluation of WBPDC shall be based on the information submitted by the bidder in response to these documents. WBPDC reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in Attachment-5 of Section-V. The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
- On the basis of a written application, tender documents, will be available from the office of Sr. Manager(S&P), KTPS, Mecheda, from Monday to Friday (excluding Saturdays, Sundays & Holidays) from 10.30 Hours to 14.00 Hours during all working days against payment of cost of the tender document by cash.
- Tender papers are not transferable. Cost of Bidding Documents is Nonrefundable.
- The offer must accompany the Earnest Money as indicated above failing which it will be summarily rejected. Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered.
- The WBPDC reserves the right to reject any tender or all tenders received at its discretion without assigning any reason whatsoever.
- The WBPDC is not necessarily bound to accept the lowest offer. Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.
