Job: Annual Maintenance Contract on Turbine & Auxiliary Systems and Piecemeal Job of Unit-1 to Unit-5 (5 x 210 MW), BkTPP.

1. Valid I.T & S.T., Service Tax Registration, Professional Tax Clearance, Certificates, Provident Fund A/c No.
2. Credential of similar work done directly under a Government/ Quasi Govt. Organization/private power generating company during last five years reckoning from 31.12.2013 with a satisfactory completion certificate indicating the main work order no. and the value of work.
 - **Similar type of job means maintenance contract in any thermal power plant having unit of 200/210 MW capacity in Turbine & Auxiliary area with experience in steam turbine, vertical & horizontal pumps, valves etc.**
 - The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
 - a) In Single order of value not less than- Rs. **1.42** Crore.
 - b) In two orders each of value not less than- Rs. **0.89** Crore
 - c) In three orders each of value not less than- Rs. **0.71** Crore
3. Average annual turnover in last three financial years (viz. year 2010-11,2011-12, 2012-13):- Rs. **0.53** Crore.
4. Average net worth in last three financial years: - should be positive.
5. Audited balance sheet for last three financial years.
