Job: Annual Maintenance Contract for Servers, Work Stations, PCs & Laptops & Necessary networking hardware & accessories Used in DCS and PLC HMI system of Unit #1 to Unit# 5 of Bakreswar Thermal Power Project

The agencies should submit the following documents in their quotation while submitting the offer:

- (i) Valid I.T & S.T., Service Tax Registration, Professional Tax Clearance, Certificates, Provident Fund A/c No.
 - (ii) Credential of similar work done directly under a Government/ Quasi Govt. Organization/private power generating company during last **three** years reckoning from 31.12.2013 with a satisfactory completion certificate indicating the main work order no. and the value of work.
 - iii) The bidder shall maintain proper organization in terms of resources, vital Spares & office premises located within a distance of **200 KM from BkTTP**.
 - iv)The bidder should have sufficient experience of at least **5 years** of successfully maintaining Servers, Work Stations, PCs & Laptops & necessary networking hardware & accessories used in DCS and PLC HMI system specially ONLINE DEC Alpha Servers in an Open VMS environment at any Thermal Power Station of which one unit should have the capacity of 210 MW Unit or above. Other DCS System servers and workstations include HP Proliant and IBM Servers. The bidder should also have experience in Windows domain comprising of Servers and workstations and related operating systems software.
 - v) Engineer responsible for maintaining DEC Alpha Servers and Workstations should be capable of installing & configuring the Open VMS on Alpha Servers & Workstations, taking image backup of HMI system (PMS of ABB make) by Tape Drive, inserting the license in the existing network environment. The company should possess enough experience in both Hardware and Software configuration of DEC Alpha workstations and DEC Alpha Servers.
- The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
- a) In Single order of value not less than- **Rs30.0 Lakh**
 - b) In two orders each of value not less than- **Rs18.5 Lakh**
