Sealed tenders in prescribed form are invited 3 part Bid [Part I: Bid Guarantee (EMD) Part II: Pre bid qualification Part III: Price Offer] for the following works at Bakreswar Thermal Power station under The West Bengal Power Development Corporation Limited from interested, resourceful and experienced agencies.

- **Job: Evacuation of settled ash from guard pond at BkTPP.**

The agencies should submit the following documents in their quotation while submitting the offer:

- (i) Valid I.T\ S.T., Service Tax Registration, Professional Tax Clearance Certificates, Provident Fund A/c No.
- (ii) Credential of **similar work** done directly under a Government/ Quasi Govt. Organization/private power generating company/coal Company during last five years reckoning from 31.12.2013 with a satisfactory completion certificate indicating the main work order no. and the value of work, scheduled and actual time of completion. The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
 - a) In Single order of value not less than- **Rs. 16.00 lacs**
 - or-
 - b) In two orders each of value not less than- **Rs. 10.00 lacs**
 - or-
 - c) In three orders each of value not less than- **Rs. 8.00 lacs**
- (iii) Average annual turnover in last three financial years (viz 2010-11, 2011-12, 2012-13):- **Rs. 6.00 lacs**
- (iv) Average net worth in last three financial years:- should be positive.
- (v) Audited balance sheet for last three financial years.
- (vi) **Similar type** of job means Evacuation of settled ash from Ash retaining structure by mechanical means and disposing the same outside plant premises, at land arranged by the agencies in an **Eco-friendly** manner complying with all statutory norms of the WBPCB to prevent pollution hazards during execution of the job.

- **Job Description: Evacuation of settled ash from guard pond at BkTPP**

- **Duration of Contract: 03(three) months.**

- **Last date of submission of tender papers:** 08/05/2014 up to 15-00 hrs. and the same will be opened at 15-30 hrs. on the same date in presence of the participating tenderers. Sealed tenders of the parties only who have deposited the requisite amount of Earnest Money will be opened for 2 part Bid [Part I, Part II]. Tender document can be obtained from Contract Cell, 3rd Floor Administrative Building, BkTPS, WBPDCCL on the dates as mentioned above, after submission and verification of the above documents and thereafter depositing the cost for tender documents at our cash office. The Corporation reserves the right to accept / cancel any or all tenders or to split the work without assigning any reason whatsoever. The WBPDCCL does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDCCL authority. The validity of tender will remain effective for 6 (Six) months from the date of opening of Price Bid of tender. All other details are available in the tender document.
