Job: Annual Maintenance Contract for Regular Cleaning of Power House Area (Boiler, Turbine & Auxiliary Equipments) of Unit # 1, 2, 3, 4 & 5 of BkTPP.

- c) In three orders each of value not less than- Rs. **17 Lakh**
- (iv) Average annual turnover in last three financial years (viz. year 2010-11,2011-12, 2012-13):- Rs. **12.75 Lakh**
- (v) Average net worth in last three financial years: - should be positive.
- (vi) Audited balance sheet for last three financial years.
