INVITATION FOR COMPETITIVE BIDS FOR PROCUREMENT OF 2750 METERS CONVEYOR BELT, HEAVY DUTY, IS 1891 PT – 1, STRENGTH – 1000/4, WIDTH – 1200 MM FOR CHP OF KOLAGHAT THERMAL POWER STATION (6X210MW)

1.0 Kolaghat Thermal Power Station (KTPS) of The West Bengal Power Development Corporation Ltd. (WBPDCCL) invites sealed tenders containing technical, commercial and price offer in duplicate(one original & one copy) from eligible bidders for Procurement of Conveyor Belt, Heavy duty, IS 1891 Pt – 1, Strength – 1000/4, Width – 1200 mm For CHP.

2.0 Quantity : 2750 Meters.

3.0 Schedule of Completion of Supply

- i) First Phase of supply (1500 meters.) shall be completed by -- 2 (two) months from the date of issue of Letter of Award.
- ii) Second Phase of supply (1250 meters) shall be completed by --4 (four) months from the date of issue of Letter of Award.

4.0 Details of Tender

On presentation of requisite money receipt against applicable cost of tender documents, the same will be handed over to the respective Bidder (s).

- a) Cost of one set of tender document : INR. 2,000.00 By Cash or by crossed Demand Draft/ Pay Order drawn in favour of "The West Bengal Power Development Corporation Limited" and payable at Mecheda, Purba Medinipure. WB.

- f) Validity of the Offer : 120 (one hundred twenty) days from date of opening
- g) Bid Security/EMD : Rs. 1,00,000/- (One Lakh only)
All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:
By Crossed Demand Draft / Pay Order or by Bank Guarantee amounting to

INR 1, 00,000.00 (Rupees One Lakh only); DD/Pay Order shall be drawn in favour of “The West Bengal Power Development Corporation Limited.” and payable at Mecheda, Purba Medinipur, WB. BG shall be issued by an Indian Branch of any scheduled bank. The Bank Guarantee shall remain valid for a period of 180 days (with additional claim period of 30 days) from the date of opening of the tender. Details of the above and the other terms and conditions have been specified in the Conditions of Contract. Govt./ Govt. Undertaking/SSI/NSIC units are exempted from deposition of Earnest Money. Valid documentary evidences shall be submitted by the bidder along with his bid in order to avail such exemption

5.0 Scope of Work/Supply

Supply of Conveyor Belt for KTPS as detailed below:

6.0 Qualification Requirement and Eligibility Criteria for Bidders

5.1 The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conations as laid down in the Bid Document is liable to be rejected.

- i. Is a manufacturer who regularly manufactures Conveyor Belts with same material specifications **or higher strength, size & nature** and has adequate technical knowledge and relevant experience.
- ii. Bidders must have supplied Coal Conveyor Belts (Width \geq 1200 mm.) at least 10,000 mtrs. in last 3 yrs. (as on the date of bid opening) with same or higher specifications to any PSU (State / Central)/ Govt. Organizations through single or multi orders.
- iii.
 - a) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to **FY 2012-13**.
 - b) Has a minimum annual turnover of Indian Rupees **100** Million each of the last three financial years.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in **Attachment-1 (Form-I) of Section-V** of the tender documents.

- iv. Has an adequate design, manufacturing and/or fabrication capability including In-house Testing facility including Chemical & Physical and capacity available to perform the work properly and expeditiously within the time period specified. A recent Test & Inspection Certificate (dated not earlier than one year from the date of tender) issued for the material by a reputed Test house / Govt. approved Test house shall be submitted by the bidder.

- v. Has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.

AND

- 5.2 In addition to the requirements stipulated at Para 6.1 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-
- 5.2.1 The bidder shall submit at least two (2) un-priced Purchase Order copy of similar work executed by him during last three (3) years in any PSU (State / Central)/ Govt. Organizations as on the date of submission of Bid along with Goods Received Note(GRN) from the End-users for the respective supply.
- 5.2.2 The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 3 years giving detailed particulars such as quantity, Size, contract value, name of the Owner, year of supply, etc.

AND

- 5.3 Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.
- 5.4 Evaluation of WBPDCCL shall be based on the information submitted by the bidder in response to these documents. WBPDCCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- 5.5 The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in **Attachment-5 of Section-V.**
- 5.6 The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
- 7.0 On the basis of a written application, tender documents, will be available from the office of Sr. Manager(S&P), KTPS, Mecheda, from Monday to Saturday (excluding Sundays & Holidays) from 10.30 Hours to 14.00 Hours during all working days against payment of cost of the tender document by cash or crossed demand draft/pay order on any scheduled bank drawn in favour of "The West Bengal Power Development Corporation Limited" and payable in Mecheda.
- 8.0 Tender papers are not transferable. Cost of Bidding Documents is Nonrefundable.
- 9.0 The offer must accompany the Earnest Money as indicated above failing which it will be summarily rejected.
- 10.0 Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered.
- 11.0 The WBPDCCL reserves the right to reject any tender or all tenders received at its discretion without assigning any reason whatsoever.
- 12.0 The WBPDCCL is not necessarily bound to accept the lowest offer.
- 13.0 Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.
