Step-II: **Qualification bid:** Submission of documents as per following qualification requirements:

- (i) Current Income Tax return, Professional Tax and Service Tax Clearance certificate, VAT registration certificate, Provident Fund (P.F.) Registration certificate.
- (ii) Credential of similar work at least of Rs. 10,00,000/- (Rupees ten lakh only), done directly against single order under a Government/ Quasi Govt. Organization / private power generating company during last seven years reckoning from 30.04.2014, with a satisfactory completion certificate indicating the main work order no. and the value of work, scheduled and actual time of completion.
- (iii) Audited balance sheet for three financial years (2010-11, 2011-12, 2012-13) to satisfy the following criteria.
 - (a) Average annual turnover in three financial years: Rupees Seven (07) lakh.
 - (b) Average net worth in three financial years should be positive
