Step-I: Deposition of requisite amount of **Earnest Money.**

Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- Current Income Tax return, Professional Tax and Service Tax Clearance certificate, VAT registration certificate, Provident Fund (P.F.) Registration certificate.
- In case of manufacturing units, valid 'Consent to operate' of WBPCB is to be furnished.
- Audited balance sheet for three financial years (2010-11, 2011-12, 2012-13) to satisfy the following criteria.
 - Average annual turnover in three financial years : Rupees Ninety (90) lakh.
 - Average net worth in three financial years should be positive.
- Experience of having successfully completed similar works of lifting of dry fly ash from silos of Thermal power Plant in Bulk/Browsers/Closed containers during last seven years ending last day of month previous to the one in which applications are invited, should be either of the following :-
 - One contract for lifting of a minimum 80% of the annual bid quantity.
 - Two contracts each for lifting of a minimum of 50% of the annual bid quantity.
 - Three contracts each for lifting of a minimum of 40% of the annual bid quantity.

Step-IV: Price Bid.

Bid documents can be obtained from (M&C) dept. on the basis of written application to GM(M&C), Corporate office, WBPDC, during working days on submission of cash only.

Tenderers must deposit earnest money by demand draft/pay order in favour of 'The West Bengal Power Development Corporation Limited' drawn on / issued by any Nationalized / Scheduled Bank, Kolkata, in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.

The date of sale, receipt and opening of bids shall be as per the following schedule:

Date of Sale : From **20/05/14 to 28/05/14** from 11.00 hrs. to 15.00 hrs.
on all working days (except Saturday/Sunday/holiday)

Last date of Receipt/Submission : **10/06/14** up to 2-30 P.M.

Date of opening bid : **10/06/14** at 3-00 P.M.

In case due to unforeseen reasons the date of submission & opening becomes a holiday or in case of any unavoidable circumstances whatsoever, in that event the same will be received & opened in the next working day at the same time & venue.

The Corporation reserves the right to accept / cancel any or all tenders without assigning any reason whatsoever. The WBPDC does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDC authority. The validity of tender will remain effective for 6(Six) months from the date of opening of Price-Bid of tender.
