Job: Annual Service Contract for Chemical Treatment of Cooling water system of Unit # 1,to 5 of RkTPP

- (ii) Credential of similar work done directly under a Government/ Quasi Govt. Organization/private power generating company during last **Five** years with a satisfactory completion certificate indicating the main work order no. and the value of work.

- a) In Single order of value not less than- Rs. 48.0 Lakh or
- b) In two orders each of value not less than- Rs. 30.0 Lakh or
- c) In three orders each of value not less than- Rs. 24.0 Lakh
- (iv) Average annual turnover in last three financial years (viz. year 2010-11,2011-12, 2012-13):- Rs. 18.0 Lakh
- (v) Average net worth in last three financial years: should be positive.
- (vi) Audited balance sheet for last three financial years.
