 - The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
 - a) In Single order of value not less than- Rs. **40** Lakhs

 - b) In two orders each of value not less than- Rs. **25** Lakhs
OR
 - c) In three orders each of value not less than- Rs. **20** Lakhs
