Sealed tenders in prescribed form are invited 3 part Bid [Part I: Bid Guarantee (EMD) Part II: Pre bid qualification Part III: Price Offer] for the following works at Bakreswar Thermal Power station under The West Bengal Power Development Corporation Limited from interested, resourceful and experienced agencies.

- **Job: Repairing and outside painting works for the PLC Building and hydrogen plant & FACC building; inside & outside painting of the canteen building including tit bit repairing and flooring work at power house area at BkTPP.**

The agencies should submit the following documents in their quotation while submitting the offer:

- i) Valid I.T\ S.T., Service Tax Registration, Professional Tax Clearance Certificates, Provident Fund A/c No.
- ii) Credential of similar work done directly under a Government/ Quasi Govt. Organization/private power generating company/coal Company during last five years with a satisfactory completion certificate indicating the main work order no. and the value of work, scheduled and actual time of completion. The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-

a) In Single order of value not less than- **Rs. 18.00 lacs [(10.0 lacs + 8.00 lacs) and above]**

or

b) In two orders each of value not less than- **Rs. 11.00 lacs [(6.5 lacs + 4.5 lacs) and above]**

or

c) In three orders each of value not less than- **Rs. 09.00 lacs [(5.0 lacs + 4.0 lacs) and above]**

Note: In parenthesis ('Painting work' + 'tit-bit repairing work')

iii) Average annual turnover in last three financial years (viz 2010-11, 2011-12, 2012-13):- **Rs. 7.00 lacs**

iv) Average net worth in last three financial years:- should be positive.

v) Audited balance sheet for last three financial years.

vi) Similar type of job means the bidder must be competent in carrying out painting job as well as some tit-bit repairing work (vitrified tiles/marble/terrazzo works or concrete works or carpenters/roofing works) at various buildings inside plant.

- **Duration of Contract: 06(six) months.**
- **Earnest Money Deposit:** Rs. 45.00 thousand (Rupees forty five thousand) in the form of Demand Draft or Bank Guarantee (Format of BG is available in the GCC) in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" drawn on /issued by any Nationalized/Scheduled Bank, Suri or United Bank of India BkTPP Branch. Sealed tenders of the parties only who have deposited the requisite amount of Earnest Money will be opened for 2 part Bid [Part I, Part II]. Tender document can be obtained from Contract Cell, 3rd Floor Administrative Building, BkTPS, WBPDC on the dates as mentioned above, after submission and verification of the above documents and thereafter depositing the cost for tender documents at our cash office. The Corporation reserves the right to accept / cancel any or all tenders or to split the work without assigning any reason whatsoever. The WBPDC does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDC authority.
