6.0 Qualification Requirement and Eligibility Criteria for Bidders

- 6.1 The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conations as laid down in the Bid Document is liable to be rejected.
- I. Bidder must be an experienced manufacturer of the PLC system being offered with latest technology & the same should be of proven high reliability, stable, minimum maintenance, easy troubleshooting. No system house will be allowed to quote for this project on behalf of the bidder either in supply part or execution part of the job.
- II. The bidder should have already installed & commissioned the identical system in , at least two Thermal Power Stations in India having 2 X 210 MW or higher capacity unit/s, operating at yearly average of 60% PLF or above, of any Govt. organization/undertakings/autonomous body or reputed industrial house. The Performance Certificate i.r.o satisfactory continuous running of the PLC system of same series for 02 (two) or more years at the COAL HANDLING PLANT, from such Thermal Power Stations in India of unit capacity of 2 X 210 MW or more, to be submitted.
- III. a) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the

- last three (3) financial years i.e. up to FY 2013-14.
- b) Has a minimum annual turnover of Indian Rupees 150 Million each of the last three financial years.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-1 (Form-I) of Section-V of the tender documents.

- IV. Has an adequate design, manufacturing and/or fabrication capability including In-house Testing facility including Physical & NDT and capacity available to perform the work properly and expeditiously within the time period specified. The bidder should have facility in India for conducting Factory Acceptance Test.
- V. Has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.
- VI. The series and manufactures of I/O Modules should be identical to that of the Main controller offered.
- VII. Bidder should be able to quote all the items specified in the Technical details. The copy of such previous (within a period of last two years) Purchase Order i.r.o the brought out items to be submitted along with the QR.
- VIII. Bidder should be able to complete the Erection, Commissioning jobs within 90 (Ninety) days, spanning 02 to 03 hrs. daily shutdown of CHP to sustain generation & Performance testing jobs within another 90 (Ninety) days after completion of Erection & Commissioning. A commitment in respect of the stated subject must be submitted by the bidder.
- IX. The bidder shall have to guarantee that the necessary support & services shall be executed at least for a period of 10 (ten) years from the date of placement of P.O. in regard to Hardware & System Software including all types of Spares to be supplied under this scope. Undertaking in this regard to be submitted.
- X. Bidder should be able to provide Annual Service Support to the offered system after completion of warranty period.
- XI. PLC system should support OPEN PROTOCOL SYSTEM.
- XII. The control & instrument system shall be in compliance with all applicable codes, standard, guide, statutory regulation & safety requirement in force.
- XIII. The bidder should be able to supply successfully i.r.o the complete PLC system for CHP, KTPS within a period of 06 (six) months from the date of placement of P.O.

- 6.2 In addition to the requirements stipulated at Para 5.1 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-
- 6.2.1 The bidder shall submit at least two (2) un-priced Purchase Order copy of similar work executed by him during last seven (7) years in any 210MW coal based thermal power plant as on the date of submission of Bid along with Goods Received Note(GRN) from the End-users for the respective supply.
- 6.2.2 The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 7 years giving detailed particulars such as quantity, Size, contract value, name of the Owner, year of commissioning, etc.

 Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-I of the tender documents.

- 6.3 Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.
- 6.4 Evaluation of WBPDCL shall be based on the information submitted by the bidder in response to these documents. WBPDCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.

- 6.5 The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in Attachment-5 of Section-V.
- 6.6 The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
- 6.7 Current S.T., I.T. & P.T. Clearance Certificates, Provident Fund Registration Certificates including P.F. Code No., Audited Balance Sheet and Profit & Loss Account for the last three financial years are to be submitted. Alternatively, bidder shall submit certificates from statutory authorities indicating exemption and /or non-applicability with regard to any or all of S.T., I.T. & P.T. Clearance Certificates. WBPDCL reserves the right to reject any bid if any or all of these certificates have not been submitted or if the certificate from statutory authorities indicating exemption and / or non-applicability with regard to any or all of S.T., I.T. & P.T. Clearance Certificates has not been submitted.
