- b) Audited balance sheet to satisfy the **net worth** (for the year **2012–2013**) of the intending party **not less than Rs.10 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- a) The bidder should have at least three(03) years of working experience of doing similar nature of job in any thermal power station of 200 MW capacity.
- b) The bidder should submit(along with their offer) contract of similar nature having order value not less than **Rs. 13 lakhs per annum** executed within a period of last seven years.
