#### **Empanelment of Advertising Agencies**

Applications in sealed cover are invited from Kolkata based (having registered office at Kolkata) reputed, resourceful and bonafide Advertising Agencies for empanelment in The West Bengal Power Development Corporation Limited (WBPDCL).

# The eligibility criteria for empanelment of advertising agencies are mentioned below. The advertising agency must have:-

- 1. Full accreditation of Indian Newspaper Society (INS).
- 2. 10 (ten) years of experience in doing artwork for all sorts of tenders, display and other advertisements.
- 3. 10 (ten) years of experience in Advertising & PR consultancy.
- 4. Certificates of INS Accreditation, Sales Tax & GOI Service Tax and other statutory clearances, PAN, last IT Return, etc. and must submit the same.
- 5. Municipal license
- 6. Full-fledged office establishment in Kolkata with infrastructure, fully computerized environment and manpower/creative personnel, sophisticated communication facilities including e-mail, fax, internet etc. and infrastructure link.
- 7. Skilled full-time personnel in the areas of creative copywriting, language writing, translation work, editing, visualization, and DTP operation.
- 8. Last 03 (three) years' audited balance sheets and have minimum turnover of Rs. 5 (Five) Crores per year, and must furnish the same.
- 9. Mode of payment and any other facilities/percentage of discount offered over the tariff
- 10. Client mix must cover large PSUs and other Power Utilities and Govt. Sectors. List of clients has to be submitted.
- 11. WBPDCL reserves the right to take final decision in this regard, or to modify or scrap the entire empanelment process without assigning any reason.

#### **TERMS & CONDITIONS**

- 1. Maximum 10 (ten) Applicants / Agencies will be empanelled depending upon the maximum turnover during last three years (average), subject to fulfillment of other eligibility criteria.
- 2. The empanelment will be valid for 03 (three) years, subject to satisfactory performance.
- 3. Service should be available all the time, as and when required by WBPDCL.
- 4. In case of any emergency, service must be provided on Sundays and Holidays, if required by the organization.
- 5. In case of non-acceptance of advertisement order, the same will be given to the next agency, as per internal rotational system.
- 6. If any agency refuses to accept advertisement on 03 (three) occasions, the name would be removed from the empanelment list.
- 7. The agency will attend WBPDCL's office to collect the materials within 02 hours of intimation.
- 8. The bills should be sent to WBPDCL along with the photo copies of the rate card, Service Registration no., VAT registration no., Sales Tax, Advertisement material release order, etc.
- 9. Year in which INS accreditation was given to the agency, must be mentioned.
- 10. Validity period of INS accreditation (attach proof along with application).
- 11. In case of failure to fulfill the terms and conditions and if the service is not satisfactory, WBPDCL reserves the right to delete the name of the Advertising Agency at any point of time without assigning any reason thereof.
- 12. If the agency fails to observe the time limit prescribed by WBPDCL for publication of the advertisement, no bill will be entertained for such delayed advertisement and also action will be taken as deemed fit as per conditions of the contract.

The existing empanelled Advertising Agencies of WBPDCL may also apply for fresh enlistment.

All applications must be accompanied by a crossed Demand Draft of Rs. 20,000/- (Rupees Twenty Thousand) only payable to 'The West Bengal Power Development Corporation Limited' drawn on any Nationalized Bank in Kolkata as Security Deposit which will be refunded without interest to the applicants who do not qualify.
