Minimum Qualifying Requirement of a bidder:

- 1. The bidder must have wide experience in painting of streetlight poles/ bus duct/ transformers/ structures for switch-yard equipments/any industrial electrical equipments particularly in the Thermal power plants within previous Three (03) years.
- 2. Experience in painting in the above mentioned area in any reputed Government / Public sector organizations is required.
- 3. The bidder is required to submit copy of work order (not older than three years) of one similar completed work costing order value not less than Rs. 80,000 /-. 'OR'
 - Two or more similar completed works costing not less than Rs. 50,000/- each in a single financial year.
- 4. The bidder has to furnish up-to-date IT Return, EPF/PF Code, & Service Tax Regn.No.
- 5. The documentary evidences showing fulfilling the above qualifying requirements must be submitted by the bidder.

Documents to be attached with TECHNICAL BID (signed and duly stamped):

- a. Photocopy of PAN No. of the Firm/Dealer/Proprietor.
- b. Photocopy of Trade license.
- c. Photocopy of Necessary Order copies to establish above mentioned minimum eligibility criteria.

 - -The prices should be indicated in words and figures without any overwriting/erasing which, such bid shall be rejected outright.

Scope Of Work with Supply of Paints:

- 1. Cleaning of the surface area of street-lighting poles with jute or cotton cut pieces to remove all dust and dirty or oily substances deposited in the corners and narrow gaps.
- 2. Chipping out the old scale, blisters etc. if any, from the rusted part of the structures.
- 3. Removing of dust, rust and old paint by hard wire brush and hard emery paper.
- 4. Cleaning of the surface by scrubber or brush or light alkaline substance to remove oily substances.
- 5. Two coats of **Berger/Asian Paints/ Nerolac/ ICI make anticorrosive red oxide primer** is to be applied on the pole structures with proper care to fully cover up every corners, gaps etc of the structures.
- 6. Two coats of **Berger/Asian Paints/ Nerolac/ ICI Aluminum paint** is to be applied finally to cover up whole pole structure giving extra care to fill up every narrow gap, corners and inside part. While painting the structures, necessary measure is to be taken to avoid drop of paint falling on any electrical parts.
- 7. Proper size brushes to be used for painting purpose.
- 8. Two coats of **Berger/Asian Paints/ Nerolac / ICI make synthetic enamel paint (Black)** is to be used from the base (ground level) of the poles up to the height of 01(one) meter.
- 9. Every pole should be numbered as directed by the Controlling Officer. Marking should be done with Black colour on Yellow background and lettering size should be minimum 2"x2".
- 10. The junction box fitted with the pole also to be painted.
- 11. After completion of every step, necessary clearance should be taken from the Controlling Officer for further work.
- 12. Sealed paint container should be used after inspection of the controlling officer.
- 13. The bidders may inspect the respective poles as sample prior to submit their quotations.

Terms & Conditions:

- 1) All the painting materials such as Primer and Aluminium paints, Thinners etc are to be supplied by the party.
- 2) Electricity and water will be provided by WBPDCL at free of cost at site used only for the purpose of the said job. Necessary arrangements for extension of power and water up to the exact location of the job will be done by the party.
- 3) All consumables, tools-tackles & man power required for execution of the job will be supplied by the party.
- 4) The order will be valid for Four (04) months only from the date of issuance of the service order. The party has to execute the job as per discretion of the controlling officer. The party may paint more than one pole simultaneously. Expected duration of execution of job is October- November, 2014.
- 5) If the party will not be able to complete the jobs within the stipulated time due to any reasons like delay of worker mobilization at site, unavailability of painting materials, machines and toolstackles, shortage / unavailability of workers etc. then the party will be totally responsible for it. In that case penalty may be imposed on the said party @5% of the total order value.
- 6) The party has to arrange own accommodation for their workers. In any case WBPDCL will not be liable for providing accommodation.
- 7) For painting the street lighting poles, necessary arrangements like scaffolding (including materials like bamboo, ropes etc) have to be arranged by the party solely.
- 8) Satisfactory job completion certificates (Original) typed on the party's letter head duly signed by the party, STPS must be submitted along with the each bill to the controlling officer.

- 9) After completion of painting of each pole any garbage like paint containers, brasses, piece of bamboo, cut-piece of clothes, emery paper, etc lying in the vicinity of poles must be cleaned by the party within stipulated time.
- 10) Payment will be made to the party on the basis of actual number of painted poles but only 90% payment may be released in bill and remaining 10% payment of the said bill may be released after expiry of 1 year guarantee period.
- 11) Validity: The tender shall remain valid for 90 (ninety) days from the date of opening.
- 12) **Guarantee Period:** 12 (Twelve) months from the date of completion of the work.
- 13) If any offer is incomparable due to ambiguity in the subject offer, the same is liable to be rejected as per sole discretion of the WBPDCL.
