2. Eligibility criteria:-

a) Must have experience of similar type of job or civil construction/ maintenance job of individual order value not less than Rs 8,48,840.00 during at least one out of five preceding financial years for which completion certificate or work order with schedule is to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid.

b) Must be financially strong :-Balance sheets with profit & loss account for the consecutive two financial years of last three years or current Bank Statement are to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid & pre-qualification bid.

c) Must be technically capable:-

Tender paper will be sold to each of the applicant. Necessary documents i.e. attested photocopies of VAT/ST Registration certificate with current return, PT Challan, Last PF Challan with valid PF registration certificate, IT PAN, Last copy of insurance under W.C.Act, Service Tax Registration certificate with current return are to be submitted along with tender paper in part-II i.e. Technocommercial bid. Request for tender paper by post will not be entertained.

4. Prebid discussion: - Pre bid discussion will be held on 09.09.2014 (if required) in presence of attending applicants. Any decision, as a outcome on the discussion will be binding on all of the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.

5. Receipt of Tenders: - Upto 14.30 hours on 11.09.2014 to be submitted in three parts i.e. i) Earnest Money, ii) Techno commercial qualification bid and iii) Price bid in separate sealed covers. The tender is to be submitted in the tender box available at the office of Sr. Manager(C)/STPS.
