Sealed tenders in prescribed form are invited for the following work at Corporate Office, Kolkata-700098, under The West Bengal Power Development Corporation Limited, from interested, resourceful and experienced agencies:

Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- (i) Current Income Tax Return, Professional Tax and Service Tax Clearance Certificate, VAT Registration Certificate, Provident Fund (P.F.) Registration Certificate, Excise Registration., ESI Code/Workman Compensation, Trade License, Labour License as applicable & Electrical supervisory license etc.
- (ii) Audited balance sheet for three financial years (2011-12, 2012-13, 2013-14) to satisfy the following criteria.
 - (a) Average annual turnover in three financial years : Rs.5.8 lacs.
 - (b) Average net worth in three financial years should be positive.
- (iii) Credential of execution of similar type of work, directly under the Government/ Quasi Govt. organization / Power Plant **during the period of last five years** in the following manner :-

- In single order ? Executed value of work not less than Rs. 15.50 lacs.
- In two orders ? Executed value not less than Rs. 9.50 lacs.
- In three orders ? Executed value not less than Rs. 7.75 lacs.
- The completion certificate shall clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.

Step-III: Techno Commercial Terms and condition: All the pages of the tender document including all the documents (except particularly mentioned document) to be submitted by the bidder shall be duly signed / authenticated and stamped in acceptance.

Job Description: Non-comprehensive Bi-annual Operation & Maintenance Contract of HT & LT Electrical system at WBPDCCL, Corporate Office, Bidyut Unnayan Bhaban, Plot No.3/C, LA Block, Salt Lake, sector-III, Kolkata-98.

Contractual period: Two years.

Cost of Tender Paper: Rs.2,000.00 in cash only (Non refundable).
