Sub: Tender Notice for Overhauling of BHEL make ESP, Ash handling Plant and C&I related job of Unit# 2 of BkTPP.

The agencies should submit the following documents in their quotation while submitting the offer:

1. Valid I.T & S.T., Service Tax Registration, Professional Tax Clearance, Certificates, Provident Fund A/c No.
2. Credential of similar work done directly under a Government/ Quasi Govt. Organization/private power generating company during period of any three year within last five years reckoning from 31.12.2013 with a satisfactory completion certificate indicating the main work order no. and the value of work.
 - **Similar type of job means Overhauling of BHEL make ESP , Ash handling Plant and C&I related job (having Wet and Dry mode of ash conveying system) of any Thermal Power Station having at least one unit capacity of 210 MW or more in combined order or separately.**
 - The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
 - a) In Single order of value not less than- ₹ 19.2 Lacs AHP, ₹ 18.3 Lacs for ESP & ₹ 0.64 Lacs for C&I
or
 - b) In two orders each of value not less than- ₹ 12 Lacs AHP, ₹ 11.5 Lacs for ESP & ₹ 0.4 Lacs for C&I
or
 - c) In three orders each of value not less than- ₹ 9.6 Lacs AHP, ₹ 9.2 Lacs for ESP & ₹ 0.32Lacs for C&I.
3. Average annual turnover in last three financial years (viz. year 2010-11, 2011-12, 2012-13): ₹ 14.3 Lacs.
4. Average net worth in last three financial years: - should be positive.
5. Audited balance sheet for last three financial years.

Overhauling of BHEL make ESP, Ash handling Plant and C&I related job of Unit# 2 of BkTPP.

Work will commence during the Overhauling period of Unit#2, which is tentatively scheduled to be held during November – December, 2014.
