# Earnest Money Deposit (PART-I):

The EMD shall be deposited in the form of Demand Draft or BG in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" drawn on /issued by any Nationalized/Scheduled Bank, Kolkata along with tender papers in a separate sealed envelope. No tender will be entertained without Earnest Money. Bank Guarantee should have validity of six months from the date of opening of tender (Part- I& II) and with a claim period of another six (06) months.

# Qualifying requirements and eligibility criteria (PART-II):

- a) Notarised copies of the following documents are to be submitted by the Bidder in support of qualification:-
- (i) Completion certificate along with work order and schedule of work from the owner for successful completion of similar type of job which means construction of minimum two storeyed RCC frame structured building including Civil, Sanitary & Plumbing, Electrical works in the last 7 (seven) years starting from 01.07.14, of value not less than as mentioned below, directly under any Government Organisation/ Undertakings/ Autonomous bodies/ any reputed concern and shall be in defect/ trouble free use for at least 1 (one) year from the date of handing over. The completion certificate should clearly indicate the main work order and the value of work, scheduled and actual time of completion and must mention about the successful completion of the entire work.

The work value for similar type jobs completed by the agency should be as follows:-

1) For 33 nos. B-Type buildings:-

- i) In Single order of value not less than Rs. 22,90,00,000/-
- ii) In two orders each of value not less than:- Rs. 14,31,00,000/-

Bidders shall have to quote the rate and amount in the 'price bid' in both figures and words.
