(STEP -I):- EARNEST MONEY : The Earnest Money of Rs. 99, 000.00 (Rupees Ninety nine thousand) only is to be deposited along with the tender offer in the form of DEMAND DRAFT on SBI SAGARDIGHI (Code No- 11377), in favour of " THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED " in a separate sealed envelope mentioning Earnest Money for tender no. & date of opening. No tender will be entertained without Earnest Money. No interest will be payable by the WBPDCL on the above Earnest Money. 9.	Evaluation of Tender :					
i)	Issuance of tender documents will not be construed to mean that such tenderers are automatically considered qualified for the entire tender process.
