Kolaghat Thermal Power Station (KTPS) of The West Bengal Power Development Corporation Ltd. (WBDCL) invites sealed tenders containing technical, commercial and price offer in duplicate (one original & one copy) from eligible bidders for Design, Manufacturing, Testing at Manufacturing Works, Supply, Delivery & Transport including transit insurance of 68 Nos. Pendant Reheater Coil for Replacement, for Overhauling of Unit#4, Due on July, 2015, through CAPEX Budget Proposal of F.Y. 2012-2013 at KTPS.

1.0 Schedule of Completion of Supply:

Supply shall be completed Within June, 2015 i.e. Approximately Within 05 months from the date of LOA.

2.0 Details of Tender

On presentation of requisite money receipt against applicable cost of tender documents, the same will be handed over to the respective Bidder (s).

All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:

By Bank Guarantee or Demand Draft – INR 3,00,000.00 (Rupees Three Lacs only) issued by an Indian Branch of any scheduled bank. The Bank Guarantee shall remain valid for a period of 120 days (with additional claim period of 30days) from the date of opening of the tender. Details of the above and the other terms and conditions have been specified in the Conditions of Contract.

Govt./ Govt. Undertaking/SSI/NSIC units are exempted from deposition of Earnest Money. Valid documentary evidences shall be submitted by the bidder along with his bid to avail such exemption.

### 3.0 Scope of Work/Supply

Supply of Pendant Reheater Coil as per the quantity and technical specifications detailed below.

### 4.0 Qualification Requirement and Eligibility Criteria for Bidders

**Technical Requirement:** The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conations as laid down in the Bid Document is liable to be rejected.

#### Must Conditions

1) The bidder must be a Designer & Manufacturer of coal fired steam generators for power plant units having rating not less than 100MW, which should be in successful operation for a period not less than two (02) years as on the date of bid opening.

AND

2) The bidder should have manufactured coils/panels of re-heaters, Superheaters, Economisers for steam generators, and such coils/panels manufactured by the bidder should in successful operation in at least one (1)Nos. of coal fired steam generators for power plant units having rating not less than 200MW for a period not less than two (02) years as on the date of bid opening.

AND

3) Bidder may assign or sublet the contract to any other sub-vendor, provided that the Annual Turn over of the Sub-vendor shall not be less than 10 (Ten) Crores, in each of the last three (3) financial years i.e. up to FY 2013-2014.

4) WBPDCCL will provide GA drawing of RH coil with tube material diagram along with tender documents.

5) Bidder should provide list of all accessories which are required for replacement of RH coil.

5.2 **Financial Requirement:** In addition to the requirements stipulated at Para 5.1 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-

1) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to FY 2013-2014.

AND

2) Has a minimum annual turnover of Indian Rupees 50 (Fifty) Crores each of the last three financial years.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-1 (Form-I) of Section-V of the tender documents.

3) Has an adequate design, manufacturing and/or fabrication capability including In-house Testing facility including Chemical & Physical and capacity available to perform the work properly and expeditiously within the time period specified.

4) Has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.

5) The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 02 years giving detailed particulars such as quantity, Size, contract value, name of the Owner, year of commissioning, etc. Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-I of the tender documents.

AND

- Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.
- Evaluation of WBPDCCL shall be based on the information submitted by the bidder in response to these documents. WBPDCCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in Attachment-5 of Section-V.
- The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
- On the basis of a written application, tender documents, will be available from the office of Sr. Manager(S&P), KTPS, Mecheda, from Monday to Friday (excluding Saturdays, Sundays & Holidays) from 10.30 Hours to 14.00 Hours during all working days against payment of cost of the tender document by cash.
- Tender papers are not transferable. Cost of Bidding Documents is Nonrefundable.
- The offer must accompany the Earnest Money as indicated above failing which it will be summarily rejected. Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered.
- The WBPDCCL reserves the right to reject any tender or all tenders received at its discretion without assigning any reason whatsoever.
- The WBPDCCL is not necessarily bound to accept the lowest offer. Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.
