- (b) Audited balance sheet for last three consecutive years (last year being 2013–14).

4.2 Technical criteria:

The Bidder shall fulfill satisfactorily the eligibility criteria requirements as stipulated under and submit documentary evidences that:-

Has executed similar nature of works (as described in clause 4.2.1 later) in single or different work orders consisting of Construction of earthen embankment, recovery water pump house and recovery water system including mechanical (supply, installation and commissioning of horizontal/ vertical pumps), electrical (supply, installation and commissioning of transformer, PMCC, motors etc.) piping (supply, laying and commissioning of MS/ ERW pipes) and

- a. Three (3) similar completed works each valuing not less than Rs. 63.0 crore
- b. Two (2) similar completed works each valuing not less than Rs. 79.0 crore
- c. One (1) similar completed work valuing not less than Rs. 126.0 crore

As a proof of the above the Bidder shall submit relevant end user's Certificates.

The Bidder shall furnish a comprehensive list of completed jobs and jobs under construction with scope of work, details of the Owner, construction details, dates when contract/s have been awarded and handed over.

4.2.1 In addition to the satisfactory fulfilment of the requirements as stipulated above, the bidders who wish to participate in the bidding shall satisfactorily establish that they fulfil the following Qualifying Requirements:

The bidder should have executed, commissioned the following works and which are in operation not less than two (2) years within the preceding seven (7) years reckoned as on date of bid opening:

- (i) At least one earthen dam work or Ash dyke work or Reservoir embankment work of maximum height not less than 6 meters in a single contract
- (ii) A cumulative progress of at least 10 lakh M³ of earth work in earthen dam work or ash dyke work or reservoir embankment or canal embankment work in a year in one or more concurrently running contracts.
- (iii)At least one RCC pump house with underground sump/ Water retaining structure

Notes: The following notes (a) to (c) explain in detail the intention of various terms of QR.

a) Earthen dams, ash dykes and reservoir embankments, which are designed as water retaining structures, shall be qualified for this work. However, canal embankments, guide bunds along water course shall be considered for qualification under Clause 4.2.1 (ii) only. All other types of

- b) For embankment / reservoir / dyke, the height and quantities shall be considered above formation level for QR purpose.
- c) Wherever the ash dykes and other embankments are constructed in different contracts, the height applicable for single individual contract only and not the cumulative effect shall be considered for the purpose of determining compliance of Clause 4.2.1 (i). For example, where the contract is for raising an embankment, only the raising portion shall be considered and not the earlier starter dyke and also not the earlier raised portion.
- d) In case of works stipulated in Clause 4.2.1 (ii) above, the word "earth work" shall mean earthwork / ash work.

(iv) Experience in supply. manufacturing, erection & commissioning of pumping system with Horizontal centrifugal / vertical pump of capacity not less than 300 M³/Hr and pipe line having minimum diameter 250 mm of length not less than 2 Km in water conveying system through MS/ ERW pipe which has been in satisfactory in operation for not less than two (2) years during last seven (7) years as on date of tender opening. The work should have included associated Electrical & Instrumentation Works as necessary for Erection and Commissioning of the Pumping system.

As documentary evidence for the above, the Bidder shall submit relevant performance Certificates by the end user for such installation.

The Bidder shall furnish a comprehensive list of all the Ash pond with recovery system / similar works (including Mechanical, Piping, Electrical & Instrumentation) under construction as well as constructed so far with scope covered, details of the
