 - **For JOB – I: Similar type of job means Annual Maintenance Contract for Operation & Maintenance of Lifts / Elevator of any Thermal Power Station having at least one unit capacity of 210 MW or more.**
 - **For JOB-II: Similar type of job means Annual Maintenance Contract for Maintenance of Telephone Exchange of any Thermal Power Station having at least one unit capacity of 210 MW or more.**
 - The value of work for similar type of job as mentioned above, completed by the agency should be as follows:
