## **Tender Notice:**

**NAME:** Open tender for procurement of HEA Igniters (suitable for BHEL Spark Model BK10) Spares and Flame Scanner (suitable for BHEL SCAN Flame Scanner System Model BN 10) Spares used for BHEL 250 MW Coal/Oil fired Boiler of STPS as per enclosed NIT Annexure.

## **INFORMATION TO BIDDERS:**

This is a Two Part bidding system containing **TECHNO-COMMERCIAL BID (Part-I)**, and **PRICE BID (Part-II)**. The same will be received and evaluated by the WBPDC, STPS from Technical and Financial point of view to make the selection in the best interest of the WBPDC, STPS for the complete work covered under the tender document. You are requested to submit your quotation, in 2 part (TECHNO- COMMERCIAL BID & PRICE BID) in 2 separate sealed envelopes mentioning TECHNO-COMMERCIAL/ PRICE BID , wrapped in a sealed cover, neatly typed, superscribing on the envelope **Name of Tender ,Tender Notice No / Enquiry No.. & Date, Due Date of Opening**, for supply & delivery of the listed materials for Santaldih T. P. S.

## **Minimum eligibility criteria of the bidder :**

- (i) The bidder must have executed at least 1 number similar type of items Supply order of value not less than Rs. 326400/- or 2 orders of value not less than Rs. 244800/- or 3 orders of value not less than Rs 163200/-. Order copies of said valuation or above received within last 3 years from Govt. of India/ West Bengal /Public Sector Undertakings (PSUs)/Other Corporates are to be attached.
- (ii) The bidder not been blacklisted by the Deptts. /Ministries of the Govt. of India/ West Bengal /Public Sector Undertakings (PSUs)/Corporates. Self declaration has to be given.
- (iii) The bidder must have Documents of Valid VAT/CST (as applicable) Registration and PAN card.

## **Documents to be attached with TECHNICAL-COMMERCIAL BID (signed and duly stamped):**

- 1) Photocopy of PAN Card of the Firm/Dealer/Proprietor.

  - Price Bids showing rates like "Tax Included/Inclusive of tax/Tax paid" etc. are not acceptable and such offer shall not be considered.
  - Any violation of the above mentioned terms & conditions shall lead to rejection of submitted offer.
- b. Literature (if any) of the quoted material.
- c. Price list of manufacturer or any other document as offered price justification.

### **Opening of Tender:**

- 1) The tenders shall be opened in presence of representative of the prospective bidders, if available, at the time and date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the prospective bidders who have submitted the tender documents. The Prospective bidder's authorized representative (up to two persons) may attend the opening.
- 2) The due date and time of opening of Techno-Commercial Bid of bidder is after 3.00 P.M. on 01.12.2014. After opening the main cover, the envelope containing Techno-Commercial Bid (Part-I) shall be opened first and if Techno-Commercial Bid is found in line only then Price Bid (Part-II) shall be opened.
- 3) Price Bid (Part-II) of tender of those prospective bidders who will satisfy qualifying requirements and who will qualify the Technical and Commercial Bid of this tender shall be opened subsequently on the same date or at a later date. The due date & time of opening of price bid will be duly intimated.

### **Evaluation of Tender:**
