This is a three (03) Steps bidding system containing (i) Earnest Money: Step -I, (ii) Qualifying Requirement, Techno-Commercial Qualification Bid: Step –II & (iii) Price Bid: Step-III and the same will be received and evaluated by WBPDCCL from technical qualification and financial point of view so as to make a selection in the best interest of WBPDCCL for the complete work covered under the tender document.

Tender document consists of the following:

1.	<b>(STEP -I):- EARNEST MONEY :</b> The Earnest Money of <b>Rs. 27, 000.00/- (twenty seven thousand only)</b> is to be deposited along with the tender offer in the form of BANK DRAFT/PAY ORDER payable on <b>SBI SAGARDIGHI (Code No- 11377)</b> , in favour of “THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED” in a separate sealed envelope mentioning Earnest Money, tender no. & date of opening of the Tender. No tender will be entertained without Earnest Money. No interest will be payable by the WBPDCCL on the above Earnest Money. Earnest Money of unsuccessful tenderers shall be refunded to them within three months from the date of issue of work order to the successful bidder/s. WBPDCCL reserves the right of forfeiture of Earnest Money deposit in case the tenderer after opening of tender, withdraws, amends, impairs, derogates, or revokes his tender within the validity period or extension thereof.
2.	<b>(STEP-II): QUALIFYING REQUIREMENTS:</b> Documents in support of qualifying requirement of tenderers as stipulated in the Notice Inviting Tender and further classified as below :-
i)	Must Possess <b>valid IT, VAT, Professional Tax clearance certificate</b> , Solvency certificate from a nationalized bank <b>and Provident Fund A/C No.</b> Service Tax registration No. & other statutory coverage.
ii)	Must have <b>sufficient credentials</b> regarding experience of execution of <b>similar nature of jobs done having value not less than Rs. 10.0 (Ten) lakh at least once in a single contract during the last three (03) years</b> directly under the Central or State Govt. Organization / Undertaking/Govt. Autonomous bodies incorporated under the Indian Companies’ Act.
iii)	<b>Audited Balance Sheet and Profit &amp; Loss account</b> for last three years from Chartered Accountant of the intending party.

3.	Addenda to tender documents if issued prior to the opening of the Tender to clarify documents or reflect modification in the design of the contract terms. All such Addenda issued shall also form a part of the Tender Documents.
4.	Minutes of the meeting of the <b>Pre-Bid</b> Discussion to be held on: 19.11.2014 <b>at 3-30 P.M.</b> Jointly along with the tenderers and the WBPDCCL shall be taken as part to form the Tender Documents.
5.	<b>TECHNO – COMMERCIAL:</b> - Acceptance of the Techno-Commercial Terms and conditions as mentioned in the Tender Document.
6.	<b>(STEP-III): PRICE –BID:</b> - RATE SHOULD BE QUOTED AS PER ENCLOSED PRICE BID.
7.	<b><u>Mode of submission of tender :</u></b>
i)	All separately sealed envelopes containing necessary documents shall have to be suitably superscribed as 'EMD- Step-I' / 'Qualifying Requirements, Techno-Commercial, Step-II' shall bear reference to the name of the work and Notice Inviting Tender ( NIT ).Price Bid i.e. Step-III will be opened later by intimating to successful parties.
ii)	All the above three (03) nos. sealed envelope (as mentioned in sl. no.7 [i]) should be kept in a common sealed envelope must be superscribed with reference to the name of the work, Notice Inviting Tender (NIT), Date of opening of the tender and Name of the Tenderer, should be dropped in the tender box marked Civil-OPH kept in 3 <sup>rd</sup> floor of the GM Building, SgTPP.
iii)	Tenderers which propose any alteration in the scope of work or in the time allowed for carrying out the work or which contain any deviation whether technical or commercial will be liable for rejection. Conditional tender are also liable to be rejected.
iv)	The tender shall be submitted in person in the manner as mentioned above (sl.no.7 [ii]). <b>Tenders submitted by post or Telegraphic etc. shall not be entertained.</b> The tenders received after the due date and time of opening is liable to be rejected.
v)	All the cost and expenses incidental to the submission of the tender, cost of Technical Survey, discussions, conferences if any, shall be to the account of the tenderer irrespective of whether the tender is accepted or not and the owner shall bear no liability whatsoever on such cost and expenses.
vi)	The tender submitted by a tenderer shall become the property of WBPDCCL and WBPDCCL shall have no obligation to return the same to the tenderer.
8.	<b><u>Opening of tender :</u></b>
i)	The tenders shall be opened in the presence of representatives of the tenderers the time and date set for opening of tender as specified hereunder or in case any extension has been given there to on the extended tender opening date and time notified to all the tenderers who have purchased the tender documents. Tenderer's authorized representatives (upto two persons) may attend the opening.
ii)	The due date and time of opening of Tender (i.e., STEP – I & II) is <b>on: 21.11.2014 at 3-30 p.m.</b> After opening the main cover, the envelope containing EMD shall be opened first if EMD is submitted as per norms the Qualifying Requirements and Techno-commercial part will be opened (step-II). Price bid (STEP – III) offer in original shall be opened if EMD of

	requisite amount and in proper mode have been submitted by the tenderer later.
9.	<b><u>Evaluation of Tender :</u></b>
i)	Issuance of tender documents will not be construed to mean that such tenderers are automatically considered qualified for the entire tender process.
ii)	The owner reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the owner shall not be subject to question by any tenderer and the owner shall bear no liability consequent upon such decision and the tenderer shall have no claim in this regard against WBPDCCL.
iii)	Evaluation by WBPDCCL shall be based on the information and documentary evidence submitted by the tenderer in response to the tender documents. The requirements as stipulated in the tender documents are the minimum and WBPDCCL has the right to request for additional information and also reserves its right to reject any tender , if in the opinion of WBPDCCL the qualification data / documentary evidence submitted by the tenderer is incomplete or tenderer is found not qualified to satisfactorily perform the work. WBPDCCL reserve the right to reject any tender if the tenderer is found to be qualified by giving incorrect and/ or false informations.
iv)	WBPDCCL does not bind itself to accept the lowest tender and also reserves the right to split the work amongst more than one tenderer.
v)	Notwithstanding anything stated above or elsewhere, WBPDCCL reserves the right to assess the capability and capacity of the tenderer, should the circumstances warrant such assessment in the overall interest of the WBPDCCL.
10.	<b><u>VALIDITY OF TENDER:</u></b>
	The tender submitted shall be deemed to constitute an agreement between the tenderer and WBPDCCL whereby such tender shall remain open for acceptance by WBPDCCL for a period of 4 (four) months from the date of opening the tender, during which period, the tenderer shall not withdraw his tender or amend, impair or derogate their forms.
