Sagardighi Thermal Power Project, a power generating unit of The West Bengal Power Development Corporation Limited (WBPDCL) invites EXPRESSION OF INTEREST (EoI) from reputed designer & manufacturers of Turbogenerators for development & supply of spare generator rotor for its 300MW Generators, DEC, China make.

1. Outline of the scope of supply

- a. The successful bidder/ principal shall develop, design, manufacture, supply & commission the rotor in such a way that it is directly retrofitted to its existing service without any major modification of existing systems. The bidder/ principal shall adopt latest National/ International standards & state of the art engineering practices in all steps including shop tests. Any point of mechanical & electrical issues shall not be inferior to the existing rotor. The rotor shall be adequately shop tested & checked as per standards before actual supply. The design & manufacture should adequately take care of the existing operating conditions with sufficient margins.
- b. Basic specification of the existing rotor-
 - Rotor: Type-QFSN-300-2-20B, Rated output-300MW(353MVA), Rated field voltage-455VDC, Rated field current- 2075ADC, Rated speed- 3000RPM, DC resistance of field winding- 0.162766 ohms at 15degC, Insulation- Class F (temp limit in B class), No of slots-32
 - ii. Basic dimensions: 1120mm rotor OD, Rotor body length- 5100mm, Generator length- 12620mm, Journal dia- 450mm, rotor wt-52.8MT
 - iii. Excitation: Type- Static Thyristor excitation
 - iv. Cooling system: Mode- H2O-H2-H2, Rated H2 press- 0.30MPA (g).

b. Fitment & commissioning-

i. The scope includes provision of complete engineering support during installation & commissioning

c. Performance guarantee

i. The supplier shall provide adequate fitment & performance guarantee of successful operation for a reasonable period in terms of BG consistent with the order value

2. Qualifying Requirements (QR):

The bidder/ principal should meet the minimum qualifying requirements as mentioned below:

- a) Successful experience in design, manufacture & commissioning of Turbo-Generator of capacity 250MW & above in supplying at least 2-turboganerators more than 2-years in successful operation in India.
- b) Annual turnover of at least 500MINR since last 3-years.
- c) Compliance of statutory requirements
- d) Should not be black-listed by any Central / State Government / Public Sector Undertaking in India.
- e) Should have manufacturing facility in India
