2. Credential of similar work done directly under a Government/ Quasi Govt. Organization/private power generating company during period of any three year with in last seven years reckoning from 31.12.2013 with a satisfactory completion certificate indicating the main work order no. and the value of work.
 - **Similar type of job means Annual Maintenance Contract related to Periodic, Preventive, Running & Breakdown Maintenance of Cranes & Hoists in Boiler, Turbine & Ash Handling Plant area of any Thermal Power Station having at least one unit capacity of 210 MW or more.**
 - The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
 - a) In Single order of value not less than- Rs. **8. 5** Lakhs.
or
 - b) In two orders each of value not less than- Rs. **5. 2** Lakhs
or
 - c) In three orders each of value not less than- Rs. **4. 2** Lakhs.
