**Step-II**: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate or challan and Provident Fund Registration Certificate.
  - b) Audited balance sheet to satisfy the **net worth** (for the year **2012–2013 or 2013-14**) of the intending party **not less than Rs. 17 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
  - c) The bidder should be well experienced in executing similar type of contract having order value of at least **Rs. 23 lakhs per annum** within a period of last five years.

## 2. a) Technical Eligibility Criteria:

- i) The party must have a minimum three(03) years work within last five(05) years in 200 MW or above Thermal Power Plant with modern C&I system.
- ii) The party must have knowledge of calibration of digital positioners with HART & normal electro-pneumatic positioners.
- iii) The party must have knowledge of calibration of SMART transmitters with HART.
- iv) The party must have previous work experience of working with DCS & PLC panels.
- v) The party must have experience in maintenance of CCTV.
- vi) The party must have previous experience of servicing/calibration of all types of pneumatic/electrical actuators.
- vii) The party must have previous experience of working with hydraulic units including servo units, positioners, directional valves, etc.

- viii) The party must have previous work experience of analyzer instruments including O<sub>2</sub> Analyzer, CO Analyzer, Dissolved Oxygen Analyzer, pH, Conductivity, etc.
- ix) The party must have seasoned & experience manpower to work at high altitude.
- x) The party must have the capability to arrange HP welder within 12 hours after notification by the user department.
- xi) The party must have the capability to arrange Optical Fiber Cable jointer within 12 hours after notification by the user department.
- xii) The party must have previous work experience in working with DM Plant Instrumentation.
- b) The party must provide a bank solvency certificate for last financial year.
