Step-II:

- (ii) In case of ash based product manufacturing units, valid 'Consent to operate' of WBPCB is to be furnished. Authenticate certificate is required from WBPCB/ Govt. dept. as 'Fly ash is one of the raw material of their manufacturing process'.
- (iii) Audited balance sheet for three financial years (2011-12, 2012-13, 2013-14) to satisfy the following criteria.
- (a) Average annual turnover in three financial years: 30% of (Quoted quantity per month x Estimated base price x 12 x 3).
- Average net worth in three financial years should be positive.
- (iv) Experience of having successfully completed similar works of lifting of dry fly ash from silos of Thermal power Plant in Bulkers/Browsers/Closed containers during last seven years ending last day of month previous to the one in which applications are invited, duly certified by the ordering authority, should be either of the following:-
- (a) One contract for lifting of a minimum 80% of the bid quantity.
- (b) Two contacts each for lifting of a minimum of 50% of the bid quantity.
- (c) Three contacts each for lifting of a minimum of 40% of the bid quantity.
