Organization/private power generating company during period of any three year with in last seven years reckoning from 31.10.2014 with a satisfactory completion certificate indicating the main work order no. and the value of work.
 - > Similar type of job means
 - a. Successful execution of the job of round the clock operation of HVAC System (which includes main plant AC, ventilation system & different types of RACs i.e. ductable, non-ductable split AC).
 - b. Main plant AC means Central AC System with reciprocating compressor of minimum 85 TR per machine capacity.
 - c. Capable of handling of Heavy Ventilation machinery operation.
 - d. The experience of operating Centralized AC System and Air Washer system in any power plant of WBPDCL or any other power generating organization (having Unit Capacity of 210MW or more) is required.
 - > The value of work for similar type of job as mentioned above, completed by the agency should be as follows:
