2. **Credential** :The bidder should have maintenance experience on silo system in any thermal power station having rating not less than 210MW under any Govt. organization/Govt. undertaking/NTPC which also includes successful operation for atleast 05 years from the date of bid opening.Supporting documents are to be submitted to establish the capability which include P.O copy for maintenance of AHP including silo system/Dedicated silo system directly or as subcontractor.
3. Audited balance sheet of profit & loss account to satisfy the current **net worth of the** intending party is **not less than Rs. 5.00 lakhs.**

This net worth criterion is not mandatory for Govt. / Semi-Govt. organisations.

After finalisation of the **Step-II** i.e. fulfillment of the qualifying requirement and **Step-III** i.e the Techno-Commercial part., the Price-Part of the Bid i.e. **Step-IV** of the eligible tenderers will be opened later on. All tenders including its various steps shall be opened in presence of the attending tenderers. The date of opening of Price-Part of the Bid i.e. **Step-IV** shall be intimated to the tenderers whose step-II and Step-III will be acceptable to the WBPDCCL in due course of time.
