Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
2. a) Bidder must be a manufacturer of modern technology air conditioning system with PLC based electronics controller.
b) The bidder should be well experienced in executing similar type of contract for consecutive two years having single order value at least Rs. 20 lakhs per annum within a period of last five years. Preference will be given to the parties having experience in maintenance of Chinese make AC machines having capacity 800 KW or more as installed in SgTPP.
c) The party must have solvency to pay its employees in case of delay in payment by WBPDC.
d) The party should have minimum net worth of Rs.30 lakhs.
