#### **NOTICE INVITING TENDER**

## <u>Job: Supply, Erection & Commissioning of hydraulic Crane with grabbing attachment at Wagon Tippler in KTPS, WBPDCL</u>

Tender is hereby invited by the General Manager (M&C), Corporate Office, The West Bengal Power Development Corporation Limited WBPDCL for Supply, Erection & Commissioning of hydraulic Crane with grabbing attachment at Wagon Tippler in KTPS, WBPDCL, through press tendering from eligible and resourceful organization of having sufficient credential and financial capability for execution of works of similar nature.

Cost of Tender Paper: Rs. 5000.00 (Rupees five thousand only) in cash (non refundable).

<u>Information to Bidders:</u> This is a four (04) part bidding system containing Earnest Money (Part – I), Qualifying Requirement (Part-II), Techno-Commercial (Part – III) & Price Bid (Part – IV). The same will be received and evaluated from technical and financial point of view to make a selection in the best interest of KTPS, WBPDCL for the complete job along with supply of materials covered under the tender document.

**Step- I : Earnest Money Deposit: Rs. 1,00,000.00 (Rupees one lac only)** in the form of Demand Draft / Banker Cheque / Bank Guarantee, valid for six months (Format of BG is enclosed with tender document) in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" drawn on / issued by any Nationalized / Scheduled Bank, Kolkata. The requisite amount of earnest money shall be deposited along with tender papers in a separate sealed envelope. No tender will be entertained without Earnest Money.

#### **Step- II : Pre-qualification (PQR) for participation:**

- a. IT, ST, PT Clearance Certificates as applicable, VAT registration no, PF Registration Certificate, Excise documents, ESI and P.F Code Number or suitable certificate bearing exemption to any or all of above from competent authority. Legible photocopies of all documents duly attested are to be submitted along with the tender. Original copies of documents are to be produced on demand.
- b. The supplier shall essentially have their own manufacturing unit. Credential Certificate of satisfactory completion of delivery, as well as performance of Supply, Erection & Commissioning of hydraulic Crane with grabbing attachment at Wagon Tippler are to be enclosed along with the offer. Status of the organization with documentary evidence is to be furnished. In case of manufacturing units, valid 'Consent to operate' of WBPCB is to be furnished.
- c. Audited balance sheet for last three years.
- d. The Bidder shall fulfill the requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conditions as laid down in the Bid Document is liable to be rejected.
- e The agency must have past experience in Design, Manufacture, Supply, Erection & Commissioning of hydraulic equipments during the last seven years to the extent as follows:
  - a.) One order of value not less than 40 Lacs or
  - b.) Two orders of value not less than 25 Lacs each or
  - c.) Three orders of value not less than 20 Lacs each

- f. Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to FY 2013-14. The balance sheet must be positive.
- g. Has a minimum annual turnover of Indian Rupees 15 lacs in each of the last three financial years. Bidder shall provide satisfactory evidence for the same. Average net worth in three financial years should be positive.
- h. Has an adequate design, manufacturing and/or fabrication capability including In-house Testing facility including Chemical, Physical & NDT and capacity available to perform the work properly and expeditiously within the time period specified.
- i. Has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.
- j. Evaluation of WBPDCL shall be based on the information submitted by the bidder in response to these documents. WBPDCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- k. The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
- 1. Tender papers are not transferable. Cost of Bidding Documents is Nonrefundable.
- m. The offer must accompany the Earnest Money as indicated above failing which it will be summarily rejected. Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered.
- n. The WBPDCL reserves the right to reject any tender or all tenders received at its discretion without assigning any reason whatsoever. The WBPDCL is not necessarily bound to accept the lowest offer.
- o. Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.

Then Techno-Commercial Qualification (STEP –III) and Price Bid (STEP-IV) of the Tender will be opened later on a separate day whose Qualifying Requirements (STEP – II) have been accepted by WBPDCL.
