b) Audited balance sheet to satisfy the **net worth** (for the years **2012-2013 or 2013-14**) of the intending party **not less than Rs. four lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work..

**Step-IV:** Price Bid.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
