Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. a) IT return of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate/challan and Provident Fund Registration Certificate.

b) Audited balance sheet to satisfy the **net worth** (for the years **2012-2013 or 2013-14**) of the intending party **not less than Rs. 15 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.

2. a) Bidders must have to submit credential of minimum 01(one) year successful and satisfactory experience to run similar type(Chillers System) of A/C Plant at any thermal power plant of 200MW or higher capacity.

b) The bidder should be well experienced in executing similar type of contract having order value of at least **Rs. 20 lakhs per annum** within a period of last five years.

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.

Bid documents can be obtained on the basis of written application from Sr. Manager (Contract Cell), Sagardighi Thermal Power Project, WBPDCCL, during working day on submission of tender cost at our Cash Section **by cash only**.

Tenderers must deposit earnest money by demand draft/pay order in favour of 'The West Bengal Power Development Corporation Limited' payable at SBI, SAGARDIGHI (code 11377) in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
