- (i) Valid I.T., Service Tax, VAT, Professional Tax Clearance Certificates and Provident Fund A/c No.
- (ii) Credential of similar work done directly under a Government/ Quasi Govt. Organization/ reputed private organization during last seven (7) years reckoning from **31.12.2014** with a satisfactory completion certificate indicating the main work order no., value of the work, schedule and actual time of completion.

The value of work for similar type of job as mentioned, completed by the agency should be as follows:

- (a) **Three (3)** similar completed works each valuing not less than **Rs. 16.0 lakh**
- (b) **Two (2)** similar completed works each valuing not less than **Rs. 19.0 lakh**
- (c) **One (1)** similar completed work valuing not less than **Rs. 31.0 lakh**
