Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate or Challan and Provident Fund Registration Certificate.
- b) Audited balance sheet to satisfy the **net worth** (for the year **2012-13 or 2013-14**) of the intending party **not less than Rs. 3 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
2. a) The party must have **experience of at least one (01) year** in maintenance jobs of EOT cranes of capacity 30 Ton or above.
- b) The bidder should be well experienced in executing similar type of contract having single order value of at least **Rs. 4 lakhs per annum** within a period of last five years.

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money. No tender will be entertained without earnest money.
