**DESCRIPTION OF THE WORK: Job Contract for painting (Including Supply) of different pipelines under T&A Deptt. for 2 X 250 MW unit at STPS .**

The job shall be executed as per 'Scope of Work' and 'Terms & Conditions' stipulated in the Tender Documents including supply of paints.

**TECHNICAL ELIGIBILITY CRITERIA:**

- (1) The bidder must have credential of painting of pipe line / Civil Structures / M.S. Structures etc. in any (govt./semi govt.) Organization .
- (2) Valid Work Order of above Job of value
  - a) Single order having a value not less than **Rs. 10 lakhs** OR
  - b) Two orders having a value not less than **Rs. 6.25 lakhs** OR
  - c) Three orders having a value not less than **Rs. 5 lakhs**.

**ESTIMATED COST INVOLVEMENT** : Rs. 12,50,000/- (Rupees Twelve Lac Fifty Thousand only) .

**INFORMATION TO BIDDERS** : This is a Four Part bidding system containing Earnest Money (Part-I), Qualifying Requirement (Part-II), Techno-Commercial (Part-III) and Price Bid (Part-IV). The same will be received and evaluated by The WBPDC, STPS from Technical and Financial point of view to make a selection in the best interest of the WBPDC, STPS for the complete work covered under the tender document.

**1) Earnest Money** : The Earnest Money of Rs. 25,000/- (Rupees Twenty Five Thousand only). The earnest money shall be deposited along with tender papers in the form of Bank Draft / Pay Order in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" payable at United Bank of India, Santaldih Branch, Dist. Purulia or State Bank of India, Purulia Branch.

**2) Surface Area To Be painted**: Around 10000 Sq.Metre.

**3) Cost of Tender Paper**: Rs. 500/- (Rupees Five hundred only).

**4) Sale of Tender Paper**: **From 27.01.2015 to 06.02.2015** on all working days up to **15=00** hour. Sale of tender paper to the applicant will not qualify them automatically in Techno-Commercial bid. Tender paper will be sold to each of the applicants.

**5) Qualifying Requirements(Part-II)**: All the documents, as stated under are, to be submitted in a sealed envelope otherwise the tender will be treated as invalid.

Attested Xerox copy of (a) Provident Fund Certificate (Not Sub-Code Certificate) allotted by S.R.O. & R.P.F.O., (b) Professional Tax Registration Certificate, (c) PAN Card, (d) Bank Statement of previous year, (e) Latest Income Tax Return (f) Service Tax Registration Certificate, (g) Trade License Xerox Copy.(k) Credentials of Previous Experience as per **sl.no. 02** of Technical eligibility Criteria.

5.1 : The WBPDC reserves the right to cancel / accept the tender in absence of the documents at their discretion in case competent authority deems it.

5.2 : Legible photocopies of all documents are to be submitted with counter signed by tenderer . Original copies of documents are to be produced on demand.

**6) Pre – Bid Discussion** : It is intended to have a pre-bid discussion at this Office of Sr. Manager (M&C Cell), STPS on 09.02.2015 at 15=30 Hrs. to provide any additional information and furnish clarification, if any, needed on the scope of work and tender documents. Any modification or addenda to tender documents resolved shall also be part of these tender documents. Parties not attending the pre-bid discussion are also liable to abide by the output of pre-bid discussion.

**7) Last date of Submission of Complete Tenders and opening of the Bids** : 12.02.2015 upto **15=00** Hrs. and **15=15** Hrs. respectively.

## **8) Opening of Tender:**

- 8.1 : The tenders shall be opened in presence of representative of the tenderers at the time of date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the tenderers who have purchased the tender documents. Tenderers' authorized representative (upto two persons) may attend the opening.
- 8.2 : The due date and time of opening of Tender of bidder is after **15=15 Hrs. on 12.02.2015**. After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement (QR) (Part-II) shall be opened.
- 8.3 : Techno - Commercial (Part-III) of tender of those tenderers who will be considered qualified in view of Part-I and Part-II by the WBPDC, shall be opened subsequently at same or later date.
- 8.4 : Price Bid (Part-IV) of tender of those tenderers who will satisfy qualifying requirements and who will accept technical and commercial terms & conditions of this tender shall be opened subsequently at same or later date.

## **9) Evaluation of Tender:**

- 9.1 : Issuance of tender documents will not mean that such tenderers are automatically considered qualified for the entire tender process.
  - 9.2 : The WBPDC reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the WBPDC shall not be subject to question by any tenderer and the WBPDC shall bear no liability consequent upon such decision and the tenderer shall have no claim in this regard against the WBPDC.
  - 9.3 : Evaluation by the WBPDC shall be based on the information and documentary evidence submitted by the tenderer in response to the tender documents. The requirements as stipulated in the tender notice and documents are the minimum and the WBPDC has the right to request for additional information. The WBPDC reserves its right to reject any tender, if in the opinion of the WBPDC the qualification data / documentary evidence submitted by the tenderer is incomplete or tenderer is found not qualified to satisfactorily perform the work. The WBPDC reserve the right to reject any tender if the tenderer is found to be disqualified by giving incorrect and / or false information.
  - 9.4 : The WBPDC does not bind itself to accept the lowest tender and also reserves the right to split the work amongst more than one tenderer and also reserves the right to reject any or all tender or cancel the tender without assigning any reason whatsoever.
  - 9.5 : Notwithstanding, anything stated above or elsewhere, the WBPDC reserves the right to asses the capability and capacity of the tenderer, should the circumstances warrant such assessment in the overall interest of the WBPDC.
- 10) *Tenders Forms can be obtained form Sr. Manager (M&C), STPS against written application on any working day, except Saturday & Holiday, between 11=00 Hrs. and 15=00 Hrs after depositing cost of tender documents at cash counter, S.T.P.S. by cash only.***
