NOTICE INVITING TENDER

Sub: "Supply of Network Hardware, AMC and Rate Contract for Services of Network Infrastructure at WBPDCL

Tender is hereby invited by the General Manager (M&C), Corporate Office, The West Bengal Power Development Corporation Limited WBPDCL for Supply of Network Hardware, AMC and Rate Contract for Services of Network Infrastructure at WBPDCL, through press tendering from eligible and resourceful organization of having sufficient credential and financial capability for execution of works of similar nature.

Cost of Tender Paper: Rs. 1000.00 (Rupees one thousand only) in cash (non refundable).

<u>Information to Bidders:</u> This is a four (04) part bidding system containing Earnest Money (Part – I), Qualifying Requirement (Part-II), Techno-Commercial (Part – III) & Price Bid (Part – IV). The same will be received and evaluated from technical and financial point of view to make a selection in the best interest of WBPDCL for the complete job along with supply of materials covered under the tender document.

Step- I : Earnest Money Deposit: Rs. 60,000.00 (Rupees Sixty thousand only) in the form of Demand Draft / Banker Cheque / Bank Guarantee, valid for six months (Format of BG is enclosed with tender document) in favour of "**THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED**" drawn on / issued by any Nationalized / Scheduled Bank, Kolkata. The requisite amount of earnest money shall be deposited along with tender papers in a separate sealed envelope. No tender will be entertained without Earnest Money.

Step II: Qualifying Requirements:

- a) Envelope sealed and marked as **STEP-2** containing valid documents in support of qualifying requirement as given below:
- i. For supply of Items, authorization from OEM in the MAF as per Annexure-2 has to be provided by Bidder.
- ii. The company must be a "Premier Partner" or "Select Partner" of M/s Cisco. Documentary evidence must be produced along with the tender. WBPDCL may also consider a bid for technical evaluation if the vendor submits necessary document that it has applied for Select or Premier Partnership of the OEM. But, they have to submit OEM's confirmation for "Premier /Select" partnership before completion of evaluation of the Technical Bid.
- iii. Any SI Firm registered in India under the Indian Companies act 1956 is eligible for the Bid. Copy of Certificate of Incorporation or Registration in India is to be furnished.
- The company must be into this business for the last 5 years. Documentary evidence in this regard needs to be produced
- v. The Bidder shall have proper office providing support and services in Kolkata, West Bengal. Documentary evidence must be produced along with the bid.

vi. Bidders are to participate in the Bid as a single entity. Any consortium, JVs, partnerships and sub-contracting arrangement will stand disqualified.

- vii. Bidder, if presently engaged in any ongoing contract with WBPDCL, must submit "No Objection Certificate" from ordering authority.
- viii. Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted with any Govt. Agencies.
- ix. Average Annual financial turnover during the last 3 years, ending 31st March 2014, should be Rs. 900000.00 (Nine Lakhs)
- x. Net worth of the Company must be positive on last day of immediately preceding last three (03) financial years
- xi. The Bidder must have successfully completed similar works during last 7 years ending 30.10.2014 either of the following:
 - i). Three similar completed works costing not less than Rs. 120000.00 (Twelve Lakhs) without Taxes

or

ii). Two similar completed works costing not less than the amount

Rs. 150000.00 (Fifteen Lakhs) without Taxes

or

iii). One similar completed work costing not less than Rs. 240000.00 (Twenty Four Lakhs) without Taxes

Note: Supply of Active components and Installation /Erection of both active & passive components will be considered as Similar Works

b) PAN, Current Income Tax return, Professional Tax and Service Tax registration certificate, VAT registration certificate, Provident Fund (P.F.) Registration certificate, ESI code / workmen Compensation Act., Trade license as applicable.

Step III: Techno-Commercial Bid:

All the pages of the tender document including all the Annexures and GCC (Vol.-1) to be submitted by the bidder shall be duly signed / authenticated and stamped in all pages as token of acceptance

Note: Tenders submitted without the above techno-commercial requirements shall be liable for rejection.

Step IV: Price Bid:

Envelope sealed and marked STEP-4 containing signed offer document and Price Part (Annexure 6).

- Evaluation of WBPDCL shall be based on the information submitted by the bidder in response to these documents. WBPDCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- > The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
