 - a) In Single order of value not less than- ₹ 40 Lacs.
or
 - b) In two orders each of value not less than- ₹ 25 Lacs.
or
 - c) In three orders each of value not less than- ₹ 20 Lacs.
3. Average annual turnover in last three financial years (viz. year 2011-12,2012-13, 2013-14):- ₹ 15 Lacs.
