- 1.a) IT return of last year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
 - b) Audited balance sheet to satisfy the **net worth** (for the year **2013–2014**) of the intending party **not less than Rs. 15 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- 2. a) The bidder should have experience of cleaning and dumping of ash/coal for at least one(01) year at any thermal power plant in India.
 - b) The bidder should submit(along with their offer) contract of similar nature having order value not less than **Rs. 20lakhs per annum** executed within a period of last five years.
