- b) Audited balance sheet to satisfy the **net worth** (for the year **2012–2013 or 2013–2014**) of the intending party **not less than Rs. 7 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
2. a) The work experience should be at least 18(eighteen) months on cooling tower of 210 MW (or above) coal based steam power plant.
- b) The party should be well experienced in executing similar type of contract having order value of **at least Rs. 10 lacs per annum** within the last five years.
